

Downtown Los Angeles both The Criminal Courts Building, built in 1972, and the historical Continental Building, built in 1904, have significant ties to Southern California's contribution to California passing the right to vote for women in 1911. An effort which had failed fifteen years prior, and which would take another nine years until the 19th amendment gave women across the country the right to vote in 1920. Republican John Hyde Braly of Pasadena founded the "Political Equality League" to focus on getting women the right to vote in California. He was builder/owner of the Continental Building then known as "Braly Block". The twelve-story building, with a Beaux-Arts style tower, was the first sky-scraper in Los Angeles, and until the late 1950's was the city's tallest office high-rise.

The other major force, to secure women's voting rights, was through "Votes for Women Club" organized by Republican Clara Shortridge Foltz. The Criminal Courts Building, in 2002, was renamed the **Clara Shortridge Foltz** Criminal Justice Center. She was also the first female lawyer on the west coast of the United States.

According to "WeAreRepublicanWomen.org" at the request of Susan B. Anthony, Senator A.A. Sargent, a Republican from California, introduced the 19th Amendment. Sargent's amendment (also known as the Susan B. Anthony Amendment) was defeated four times by a Democrat-controlled Senate. When the Republican Party regained control of Congress in 1920, the Equal Suffrage Amendment finally passed the House in August of that year and in the Senate in June.

Ida B. Wells-Barnett, stood up against discrimination in 1884 when, with a paid first-class ticket for the train from Memphis to Nashville refused to be seated in the segregated "at the back" car; she stood up against lynching in 1898; in 1913, at the suffrage parade in Washington, D.C, refused to march in the

back with the other African American women. Instead, she marched at the front of the Illinois suffrage delegation. The quote "The way to right wrongs is to turn the light of truth upon them" is attributed to Ida B. Wells. Her parents were active in the Republican Party during Reconstruction. She campaigned for the Republican party in Illinois and Missouri in the early 1900s, participating in Chicago mayoral elections. The first woman to hold an elected Federal office was **Jeannette Rankin** of Montana, a Republican. While the media attempts to characterize all Republicans as unyielding war proponents it is interesting to note a statue of Rankin, inscribed "I Cannot Vote For War", was placed in the United States Capitol's Statuary Hall in 1985.

So, what happened to the women of the "suffragette movement" and various organizations across the country? An answer to this question is found within an accounting of the history of the 94yr old California Federation of Republican Women. <http://www.cfrw.org/history.htm>

The objective of the Federation, established in their Bylaws, was and is "to promote a wider knowledge of principles and policies of the Republican Party." PROTECTING PUBLIC RESOURCES: The Trump Administration is taking action to help ensure that non-citizens in this country are self-sufficient and not a strain on public resources.

The Trump Administration is releasing a final rule that will protect American taxpayers, preserve our social safety net for vulnerable Americans, and uphold the rule of law.

This action will help ensure that if aliens want to enter or remain in the United States they must support themselves, and not rely on public benefits.

An alien who receives public benefits above a certain threshold is known as a "public charge."

Aliens will be barred from entering the United States if they are found likely to become public charges.

Aliens in the United States who are found likely to become public charges will also be barred from adjusting their immigration status.

President Trump is enforcing this longstanding law to prevent aliens from depending on public benefit programs.

The Immigration and Nationality Act makes clear that those seeking to come to the United States cannot be a public charge.

For many years, this clear legal requirement went largely

unenforced, imposing vast burdens on American taxpayers. Now, public charge law will finally be utilized.

ENCOURAGING SELF-SUFFICIENCY: Self-sufficiency has long been a basic principle of our Nation's immigration laws that has enjoyed widespread support.

Public charge has been a part of United States immigration law for more than 100 years as a ground of inadmissibility.

Congress passed and President Bill Clinton signed two bipartisan bills in 1996 to help stop aliens from exploiting public benefits.

This included the Personal Responsibility and Work Opportunity Reconciliation Act and the Illegal Immigration Reform and Immigrant Responsibility Act.

As Congress made clear at the time, it is our national policy that aliens should "not depend on public resources to meet their needs."

Americans widely agree that individuals coming to our country should be self-sufficient, with 73 percent in favor of requiring immigrants to be able to support themselves financially.

PRESERVING THE SOCIAL SAFETY NET: We must ensure that non-citizens do not abuse our public benefit programs and jeopardize the social safety net needed by vulnerable Americans.

Large numbers of non-citizens and their families have taken advantage of our generous public benefits, limited resources that could otherwise go to vulnerable Americans.

78 percent of households headed by a non-citizen with no more than a high school education use at least one welfare program.

58 percent of all households headed by a non-citizen use at least one welfare program.

Half of all non-citizen headed households include at least one person who uses Medicaid.


Guided by Preamble's eloquent words “in order to form a more perfect union," the framers of the United States Constitution drafted America's supreme law during the Philadelphia Convention of 1787. As Thomas Paine stated in Common Sense, America had the opportunity to “form the noblest truest constitution on the face of the earth” and thus “begin the world over again.” Well educated in the lessons of history, the Consti-

tutional framers including Washington, Madison, Hamilton, Jefferson, Jay, and Franklin outlined a representative republic, not a pure democracy, which preserved fundamental individual rights. On the issue of the presidency, they rejected several concepts for presidential elections including selection by Congress which would upset the balance of power, by State Legislatures which would compromise federal authority, and by popular vote which would favor more populous states. Finally, they proposed an indirect election through the College of Electors with roots in the Roman Republic and the Great Compromise. As specified in Article II, Section 1 of the Constitution, the president and vice president are chosen by electors from each state with each delegation equal to the state's number of representatives and senators. The Electoral College protects all minority populations by making it extremely difficult for any one faction to gain majority control, while balancing the geographical and political concerns

of rural and urban populations. To win 270 electoral votes, no state is irrelevant. This clever system prevents heavily populated states like California and New York from forcing their agendas on the minority states. In today's global society, the Electoral College equally protects the values of small-town America as well as the interests of cosmopolitan cities.

After President Trump's Electoral College victory in 2016, the leftist opposition began waging war on it, calling it racist. The Electoral College enabled Abraham Lincoln to abolish slavery after winning the presidency with only 39 percent of the popular vote. Although President Trump failed to win the popular vote, he won a huge majority of counties, over 80 percent. A majority of the 2020 Democratic presidential candidates now call for dismantling the Electoral College or subverting it with the National Popular Vote (NPV) where states assign all their Electors to the winner of the national popular vote. Unfortunately, NPV is subject to voter fraud, populist candidate manipulation, and small state marginalization. Without the Electoral College, a candidate in a large pool might need only 10% of the vote.

The Constitutional framers knew the flaws of pure democracy and put protections in place for America's republic – a republic that stands at the pinnacle of success in the modern world. In “Federalist Papers #68”, Hamilton and Madison wrote “if the Electoral College wasn't perfect, it was at least excellent.” The Electoral College protects the interests of a diverse nation. Liberty and the pursuit of happiness are rights for all, not just the majority. The fight to maintain the integrity of the Electoral College, a system so magnificently established 232 years ago, is critical for the sovereignty of all states!

Power is like fire. Under control, it is a force for creation, bestowing light and productivity. In excess, however, it is merely a weapon of destruction – ever consuming and catastrophic. From the flaws of Athenian democracy to the implosion of the Roman Empire, history testifies to the destructive consequences of an imbalance of power, either in the hands of the people or of the elected officials. Hence, when tasked to shape the future of a nation within the

inscriptions of a written document, the framers of the American Constitution compromised upon a federal republic rather than a pure democracy, as illustrated through the checks and balances within Congress and the Electoral College system of voting itself. Ultimately, to mitigate the threat of a tyranny of the majority, the framers established the Electoral College, which serves to protect the minority rights of citizens and prevent geographical dictatorship.

The structure of the Electoral College reflects the deliberate nature of American government, which acts as a republican restraint against popular sovereignty. With the Great Compromise of 1787, the framers established a bicameral legislature, illustrating their desire for a balance of power, as the representatives in the House proportionally align with state population, whereas in the Senate, each state is equally guaranteed two senators. Just as this legislative framework provides a check against any popular faction asserting influence, the Electoral College likewise mirrors this deliberate nature of

Congress, as Article 2, Section 1 of the Constitution enumerates that independent electors, proportional to the number of representatives in Congress, ultimately represent their states' wishes in electing the president. Therefore, in alignment with the checks and balances of Congress, the framers created the Electoral College to inhibit any despotic majority from determining an election, instead allowing electors to represent, but not be subject to, the demands of their states' majorities.

A direct democracy, however, allows for a tyranny of the majority, where individual and minority rights are muted under the booming voice of the majority. Our founding fathers intentionally created a government of the people, by the people, and for the people, not of, by, or for the majority. Their collective wisdom formed the Electoral College to channel the desires of individual states, where each individual in each state is heard. Nevertheless, if popular sovereignty decided elections, then candidates need only concentrate their efforts in larger states like California or Texas. The Electoral College, therefore, guarantees that candidates appeal at the national level, hearing both the Idaho farmer and the New York executive. In encouraging these national coalitions, the Electoral College protects the interests of each American regardless of location, thus discouraging sectional advantage while ensuring the fair representation of smaller states as well.

Therefore, the framers established the Electoral College to avert a tyrannical majority from suppressing minority rights, thus giving power and voice to all. Power truly is like fire in both creation and destruction, but with the Electoral College, it only creates an America where power roots from proficiency, not popularity.


A Closer Look at Conway's Thoughts on the 2020 Election
