<p>A permanent typo in the 1919 inscription atop the New York State Supreme Courthouse, in Manhattan, was not publicly acknowledged until 2009. It read <i>"the true administration of justice is the firmest pillar of good Government,"</i> instead of <i>"the due administration of justice is the firmest pillar of good Government,"</i>.</p> <p>It is quite possible because the grammatical integrity and intent were not lost, no correction was ever made. However, today some press and politicians are undermining and misrepresenting the role, and foundation, of the Office of the Attorney General, as well as the Department of Justice, far beyond any typo.</p> <p>President George Washington wrote to Edmond Randolph in 1789 concerning his nomination as the first United States Attorney General. "Dear Sir: Impressed with a conviction that the due administration of justice is the firmest pillar of good Government, I have considered the first arrangement of the Judicial department as essential to the happiness of our Country, and to the stability of its political system; hence the selection of the fittest characters to expound the laws, and dispense justice, has been an invariable object of my anxious concern."</p> <p>The Department of Justice describes, on their website, the Office of the Attorney General:</p> <p><i>"... created by the Judiciary Act of 1789 as a one-person part-time position. The Act specified that the Attorney General was to be "learned in the law," with the duty "to prosecute and conduct all suits in the Supreme Court in which the United States shall be concerned, and to give his advice and opinion upon questions of law when required by the President of the United States, or when requested by the heads of any of the departments, touching any matters that may concern their departments."</i></p> <p>Prior to Congress passing the 1870 Act to Establish the Department of Justice, the U.S. government had incurred expenses by using private attorneys. The 1870 Act empowered the DOJ to handle all criminal prosecutions and civil suits in which the United States had an interest; and established the Office of the Solicitor General to assist the Attorney General. The 1870 Act remains the foundation for the DOJ's authority, with only structural changes over the years. The DOJ</p>	<p><i>"The task of the Office of the Solicitor General is to supervise and conduct government litigation in the U.S. Supreme Court. Virtually all such litigation is channeled through the Office of the Solicitor General and is actively conducted by the Office. The United States is involved in approximately two-thirds of all the cases the U.S. Supreme Court decides on the merits each year."</i></p> <p>Members of the U.S. Supreme Court, in 1973, codified the non-medical trimester system. They became unelected legislators. The Office of the Solicitor General apparently did not represent, identify, or protect the interests of, legislators, voters, male citizens, and the stability of the future population of natural born citizens. However, what also occurred was a judicial path for the government to incur financial commitments, fulfilled by taxing citizens, to benefit a private corporation (Planned Parenthood) AND for the government to impose the moralities of that corporation upon all citizens.</p> <p>This played out again in 2012, when the Court ruled the penalties the Affordable Care Act placed on people, who didn't buy mandatory health insurance, again benefiting private corporations, were a tax. This allowed the IRS to enforce the not so Affordable Care Act.</p> <p>A typo atop a building pales in comparison to this usurpation of power not granted to the U.S. Supreme Court by the Constitution. Lastly, within the DOJ website is this: <i>"Thomas Jefferson wrote, 'The most sacred of the duties of government [is] to do equal and impartial justice to all its citizens.' This sacred duty remains the guiding principle for the women and men of the U.S. Department of Justice."</i></p>

TRUMP WINS BIG FOR FREE SPEECH Fox News report

President Trump has taken a stand for free speech on college campuses, threatening their funding if they do not follow the Constitution. Fox News reports:

President Trump on Thursday signed an executive order to promote free speech on college campuses by threatening colleges with the loss of federal research funding if they do not protect those rights. “We’re here to take historic action to defend American students and American values,” Trump said, surrounded by conservative student activists at the signing ceremony. “They’ve been under siege.” “Under the guise of speech codes, safe spaces and trigger warnings, these universities have tried to

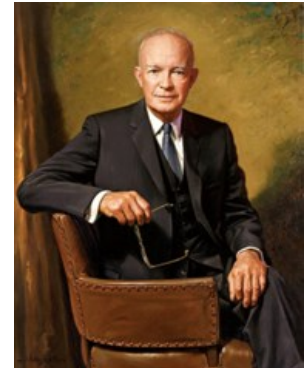
restrict free thought, impose total conformity and shut down the voices of great young Americans like those here today,” he said.

A senior administration official said the order directs 12 grant-making agencies to use their authority in coordination with the White House Office of Management and Budget (OMB) to ensure institutions that receive federal research or education grants promote free speech and free inquiry. White House officials have said it will apply to more than \$35 billion in grants.

It’s about time that conservatives stop funding institutions with tax dollars that trample on them.

PRESIDENT TRUMP SHOWS PROGRESS IN WAR AGAINST ISIS FOX NEWS REPORT

President Trump held up a map showing the dwindling territory held by the Islamic State, restricted to a single village now and surrounded by hostile forces. Fox News reports:

President Trump on Wednesday brandished a striking map showing how the Islamic State’s presence in Syria has diminished since he took office, while vowing the deadly terrorist network will be gone “by tonight” as he showed reporters the tiny spot representing their last stand.

“I brought this out for you because, this is a map ... everything in the red — this was on Election Night in 2016 — everything red is ISIS,” he told reporters, pointing to a top image that showed large parts of the region covered in red.

“When I took it over, it was a mess. Now, on the bottom — that’s the exact same — there is no red,” he said, pointing to an image below. “In fact, there’s actually a tiny spot which will be gone by tonight,” he added.

“So this is ISIS on Election Day, my Election Day, and this is ISIS now,” he said. “So that’s the way it goes.” This victory is a huge credit to the US Armed Forces and its allies. The world will be safer with this scourge destroyed in Syria.

MUELLER REPORT DOES NOT HAVE PROOF OF TRUMP CRIMES BY REUTERS MARCH 24

US Special Counsel Robert Mueller's report on Russian interference in the 2016 election did not find that President Donald Trump committed a crime but also does not exonerate him, according to a summary of Mueller's findings released on Sunday.

Mueller, who spent nearly two years investigating allegations that Russia meddled in the 2016 election to help Trump defeat his Democratic opponent Hillary Clinton, also found no evidence that any member of Trump's election campaign conspired with Russia during the election. "While this report does not conclude that the president committed a crime, it also does not exonerate him," Attorney General William Barr quoted Mueller as writing in his report on the issue of possible obstruction of justice.

Mueller said he would leave it to the attorney general to decide whether a crime was committed.

Barr's summary said Mueller found no evidence that the Trump campaign coordinated with Russia, despite multiple offers from individuals associated with Russia. The release of the summary is likely to ignite a new political fight in Washington as Democrats push for Barr to re-

Trump seizes on the findings as vindication of his near daily assertion that he was a victim of a "witch hunt" that has cast a long shadow over his presidency. Trump has always denied collaborating with Moscow or obstructing justice. Russia says it did not interfere in the election, although US intelligence agencies concluded that it did. Barr said the investigation also found insufficient evidence that Trump had attempted to obstruct justice. Many of his opponents accused him of obstructing the Russia probe when he fired former FBI director James Comey.

The Department of Justice announced on Friday that Mueller had ended his investigation after bringing charges against 34 people, including Russian agents and former key allies of Trump, such as his campaign chairman Paul Manafort, former national security adviser Mike Flynn and his personal lawyer Michael Cohen.

None of those charges, however, directly related to whether Trump's campaign worked with Moscow.

'Today' host Savannah Guthrie asks Sarah Sanders if Donald Trump owes Robert Mueller an apology

After two years, \$25.2 million, almost 3,000 subpoenas and approximately 500 witnesses interviewed, does President Trump owe Robert Mueller an apology?

That's the question NBC host Savannah Guthrie asked White House press secretary Sarah Sanders on Monday in the wake of Attorney General William Barr releasing the "principal conclusions" of Special Counsel Robert Mueller's completed Russia probe in a bombshell four-page letter to Capitol Hill lawmakers.

"Did Robert Mueller deserve better from the president than this kind of language and behavior?" Guthrie asked on "Today."

"For the last two years the president has absolutely eviscerated Bob Mueller, a lifelong public servant, a former Marine, a registered Republican.

"He's called him a national disgrace, discredited, a prosecutor gone rogue who oversaw a gang of thugs."

Sanders shot back, "Are you kidding?" before countering that Democrats had accused Trump of committed acts "equal to treason."

Guthrie returned fire: "He called Robert Mueller — he trashed him for two years, and in the end Mueller just did an investigation that ultimately the president considers a total exoneration of him."



The White House press secretary then slammed the Democrats, and parts of the media, in response.

"I think Democrats and the liberal media owe the president and they owe the American people an apology," she said.

William Barr on Sunday released the "principal conclusions" of Mueller's completed Russia probe in a bombshell four-page letter to Capitol Hill lawmakers, which stated definitively that Mueller did not establish evidence that Trump's team or any associates of the Trump campaign had conspired with Russia to sway the 2016 election — "despite multiple offers from Russian-affiliated individuals to assist the Trump campaign."

For Trump, who has tweeted more than 230 times that he did not collude with Russians amid a torrent of allegations from media and political figures, the moment amounted to a near-total vindication. Although Mueller noted that his report did not "exonerate" Trump on obstruction, Barr wrote, the "report does not recommend any further indictments, nor did the Special Counsel obtain any sealed indictments that have yet to be made public."

Hundreds Protest Rep. Ilhan Omar in Woodland Hills

U.S. Rep. Ilhan Omar faced hundreds of protesters Saturday outside a Southern California fundraising event for the local chapter of a major advocacy group representing Muslim-Americans.

"Burn the Quran!", "Ilhan Omar, go to hell!" and "Shame on you, terrorists!" were among some of the messages shouted outside a Woodland Hills hotel where the Minnesota Democrat spoke at a fundraiser for the Council of American-Islamic Relations (CAIR) of Greater Los Angeles, according to a report. The town is about 25 miles northwest of downtown L.A.

The protesters lined a sidewalk area, where they waved Israeli flags and denounced the freshman congresswoman over recent remarks that some have described as anti-Semitic, the Los Angeles Daily News reported. The atmosphere was a mix of dancing and music mixed with the vitriolic comments against Omar, the report said.

Omar, a 37-year-old immigrant from Somalia who came to the U.S. with her family in 1995, has faced a storm of criticism from pro-Israel politicians and groups after her February tweet that said "It's all about the Benjamins baby," in reference to the support that

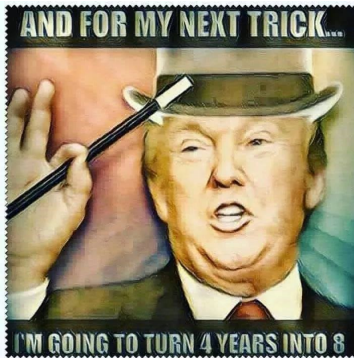

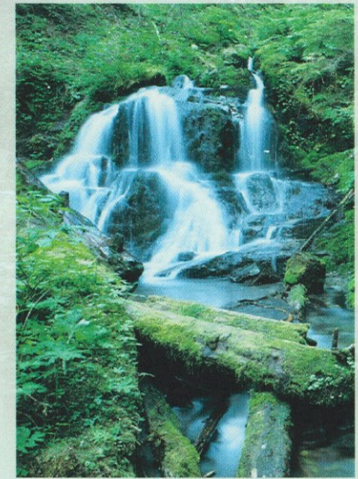

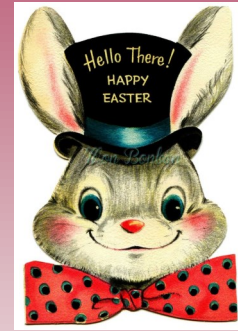
