
We have all been so busy fighting for our Country. This month it is time to think of our surroundings and our safety.

Veteran's Day

We celebrate Veterans Day on November 11th each year to honor those who served our country. We all know or are related to a veteran, but I would like to talk about some people that we might not know about. In 2014 American Legion Magazine asked readers to select 25 from a list of 100 of our most beloved veterans. These are the stories about five out of the 25.

#1. Audie Murphy. This Texas farm boy became the most decorated soldier of World War II, a Hollywood star, and a pioneer in pushing for recognition and study of PTSD. He suffered with it his entire life.

#5. George Patton. His strong leadership, knowledge of tank warfare, and his famous "dash" across Europe put him on the list of great military heroes. Although dead these 70 years, his popularity hasn't decreased because "Patton was a winner who knew how to convince his soldiers that they were winners too."

#9. Jimmy Doolittle. While working at Shell Oil, he pushed for the use of advanced aviation fuel. He returned to the Army full time in 1940 where he was a test pilot. In 1942 General "Hap" Arnold asked him to lead a raid on the Japanese mainland. This called for B25 bombers to take off from carriers (a new and novel idea), because Japan held most of the Pacific. 16 B25 bombers were rigged for doubled fuel capacity and launched from the Hornet to bomb the Japanese mainland. They didn't have



enough fuel to return to the Hornet, but went anyway and crashed their planes in China and even Russia after parachuting out. Some didn't survive. The attack was a psychological blow for the Japanese who previously had believed they were invulnerable.

#16. The Four Chaplains. On February 3, 1943, the USAT Dorchester was torpedoed. Four Army chaplains, Father John P. Washington, Rabbi Alexander Goode, and the Revs. George Fox and Clark Poling, gave their lifejackets to others as the ship sank. Of the 902 soldiers, Navy armed guard, ship's crew and civilian passengers on board, only 230 survived. They related how the chaplains' worked to keep calm in a hopeless situation. They were last seen at the ship's stern, praying with their arms linked.

#25. Lewis "Chesty" Puller. Named "Chesty" for the way he carried himself, he became the most decorated leatherneck (Marine) in history. He was awarded the Silver Star, the Distinguished Service Cross and five Navy Crosses along with many ribbons. He was a gifted leader, able to break down complex tasks so that anyone could learn them. He also had a gift for aphorism. Surrounded by Chinese troops in Korea, he told his regiment, "We've been looking for the enemy for several days now. We've finally found them. We are surrounded. That simplifies the problem of getting to these people and killing them."

Thomas Paine Scholarship

Democrat Tom Torkakson has an answer to the LAUSD problem of only 54% real graduation rate. **End the Exit Exam and give a diploma to everyone.** Why do Democrats hate to educate students, want to assure minorities do not receive a quality education and issue an absolutely worthless diploma? “Intended to serve as a hardedge performance evaluation when it was first proposed by former Gov. Gray Davis in 1999, the goal of the exam became less aggressive over the years in accommodation of public outcry and court rulings that the test posed an unfair challenge to some subgroups.

What he does not mention is that Common Core is based on dumbed down, Third World education—in a quality government school two plus two always equals four. Under Common Core, if you understand the process, two plus two can equal five. Want an engineer that believes that? No exit exam, no accountability, Common Core—a recipe to assure generations of illiterates.

Because of the shift to the Common Core State Standards in 2010, the requirement that seniors pass the exit exam as a condition of receiving a diploma was suspended beginning with class of 2015-16. The suspension is set to expire after the 2017-18 school year.

Torlakson said in a memo to the California Board of Education, the exam had outlived its usefulness as a performance screen. “California has embarked on a path toward preparing all students for college, career, and life in the twenty-first century through a focus on performance, equity, and continuous improvement,” Torlakson said.

“This is a path where (local educational agencies) take on an increased role in designing the kindergarten through grade twelve educational structures and supports for students to reach their full potential,” he explained. “Because of the comprehensive resources now available to identify students in academic need at lower grades, it is no longer necessary for the CAHSEE (high school exit exam) to continue beyond 2018.”

Breitbart has reported that Clinton's V.P. pick **Tim Kaine** is among the top anti-Israel senators. He is the top recipient of PAC funds from George Soros's anti-Israel group, J Street. He distinguished himself as one of eight senators to walk out on Benjamin Netanyahu's historic speech to a joint session of Congress warning against the so-called Iran deal.

Kaine's record on the Islamic threat here in America is far, far worse than that. In exchange for campaign contributions, he appointed a radical jihadist to the Virginia Immigration Commission. Esam Omeish runs a group described by federal prosecutors in a 2008 court filing "as the overt arm of the Muslim Brotherhood in America." Omeish is the V.P. of a radical mosque that had the al-Qaeda operative Anwar Al-Awlaki as its imam and two of the 9/11 hijackers and Nidal Hasan, the perpetrator of the Fort Hood shooting, in the congregation. Omeish was also chairman of the board of a New Jersey mosque with terrorist ties, including an imam whom the Department of Homeland Security wants to deport for having links to Hamas. As if that weren't enough, Omeish pledged in a video to help Palestinians who understand that "the jihad way is the way to liberate your land."

"When a state delegate wrote a letter to then-Governor Kaine warning him that the MAS has "questionable origins," a Kaine spokesperson said the charge was bigotry. Kaine also has close ties with Jamal Barzinji, whom the Global Muslim Brotherhood Watch describes as a "founding father of the U.S. Muslim Brotherhood. He first came on to the FBI's radar in 1987-1988 when an informant inside the Brotherhood identified Barzinji and his associated groups as being part of a network of Brotherhood fronts to "institute the Islamic Revolution in the United States."

The Source Said Barzinji And His colleagues were organizing political support which involves influencing both public opinion in the United States as well as the United States Government" using "political action front groups with no traceable ties." (snip) Barzinji was nearly prosecuted but the Obama Justice Department dropped plans for indictment. Barzinji played a major role in nearly every Brotherhood front in the U.S. and was vice president of the International Institute of Islamic Thought (IIIT), which came under terrorism investigation also.

What is truly chilling about Kaine's association with known terrorists is that the indictment of Al-Arian says the jihadist's

strategy was to "seek to obtain support from influential individuals, in the United States under the guise of promoting and protecting Arab rights." The quotes about Brotherhood operative Barzinji's aspirations to use civil rights advocacy as a means to influence politicians are especially relevant when you consider that video from the event honoring Barzinji shows Kaine saying that it was his fourth time at the annual dinner and thanked his "friends" that organized it for helping him in his campaign for lieutenant-governor and governor and asked them to help his Senate campaign.

Like Hillary, Tim Kaine's affection for jihadists is a quid pro quo: he gives them cover and appointments to positions of power, and they give him money (snip) The Barzinji-tied New Dominion PAC donated \$43,050 to Kaine's gubernatorial campaign ...The PAC has very strong ties to the Democratic Party in Virginia, with ... almost \$257,000 in donations. This likely explains why Barzin-

ji's grandson served in Governor McAuliffe's administration and then became the Obama Administration's liaison to the Muslim-American community.

The Middle East Forum's Islamist Money in Politics database shows another \$4,300 donated to Kaine's Senate campaign in 2011-2012 by officials from U.S. Muslim Brotherhood entities.... Another \$3,500 came from ... Barzinji's IIIT organization.



The New York Sun sees Kaine as one of the few senators who fully backed the Obama-Hillary Middle East disaster, including the open disrespect and hostility to our ally, Israel.

Can it be a coincidence that of all the millions of Americans Secretary Clinton could have picked as her running mate, she chose, in Senator Kaine, one of the eight Democrats who boycotted Prime Minister Netanyahu's address last year to a joint meeting of Congress? Not a chance.

Hillary's New Constitution

Clinton explains how she'll gut the First and Second Amendments. Wall Street Journal, October 21, 2016

Donald Trump is no legal scholar, but at Wednesday's presidential debate he showed a superior grasp of the U.S. Constitution than did Hillary Clinton. Amid the overwrought liberal fainting about Mr. Trump's bluster over accepting the election result (see below), Mrs. Clinton revealed a view of the Supreme Court that is far more threatening to American liberty.

Start with her answer to moderator Chris Wallace's question about the role of the courts. "The Supreme Court should represent all of us. That's how I see the Court," she said. "And the kind of people that I would be looking to nominate to the court would be in the great tradition of standing up to the powerful, standing up on our behalf of our rights as Americans."

Where to begin with that one? The Supreme Court doesn't—or shouldn't—"represent" anyone. In the U.S. system that's the job of the elected branches. The courts are appointed, not elected, so they can be nonpartisan adjudicators of competing legal claims.

Mrs. Clinton is suggesting that the Court should be a super-legislature that vindicates the will of what she calls "the American people," which apparently excludes "the powerful." But last we checked, the Constitution protects everyone, even the powerful. The law is supposed to protect individual rights, not an abstraction called "the people."

The Democrat went downhill from there, promising to appoint judges who would essentially **rewrite the First and Second Amendments**. Asked about the 2008 Heller decision that upheld an individual right to bear arms, Mrs. Clinton claimed to support "reasonable regulation." She said she criticized Heller because it overturned a District of Columbia law intended merely "to protect toddlers from guns and so they wanted people with guns to

safely store them."

Toddlers had nothing to do with it. What Mrs. Clinton calls "reasonable" was an outright ban on handguns. The D.C. law allowed the city's police chief to award some temporary licenses—but not even the police officer plaintiff in the case could persuade the District to let him register a handgun to be kept at his home.

Anyone who did lawfully possess a gun had to keep it unloaded and either disassembled or bound by a trigger lock at all times, ensuring it would be inoperable and perhaps useless for self-defense. As Antonin Scalia wrote for the Heller majority, "Few laws in the history of our Nation have come close to the severe restriction of the District's handgun ban."

If Mrs. Clinton supports such gun restrictions, then she thinks an individual's right to bear arms is meaningless. If the Justices she appoints agree with her, then they can gradually turn Heller into a shell of a right, restriction by restriction, even without overturning the precedent. Then there's the **First Amendment**, which Mrs. Clinton wants to rewrite by appointing Justices she said would "stand up and say no to Citizens United, a decision that has undermined the election system in our country because of the way it permits dark, unaccountable money to come into our electoral system."

Citizens United is the 2010 Supreme Court decision that found that unions and corporations can spend money on political speech—in that specific case for a movie that was critical of Mrs. Clinton. The Democrat seems to take the different view that while atomized individuals might have the right to criticize politicians, heaven forbid if they want to band together to do it as a political interest group.


As for "dark" money, she

certainly knows that territory. Does money get any darker than undisclosed **Clinton Foundation** donations from foreign business magnates tied to uranium concessions in Kazakhstan?

There is at least one right that Mrs. Clinton did suggest she believes to be absolute—to an **abortion, at any time during pregnancy right up until birth**. She claimed merely to oppose the repeal of Roe v. Wade, which allows some regulation of late-term abortions. But she somehow overlooked Gonzales v. Carhart, the 2007 decision that upheld a legislative ban on so-called partial-birth abortion. Justice Anthony Kennedy wrote the Carhart opinion that ruled such restrictions are consistent with Roe and the Constitution. Mrs. Clinton kept invoking "the life and the health of the mother" to justify her opposition to any limit on abortion, but Carhart found the life of the mother can be sufficient.

To put all this another way, Mrs. Clinton believes there is **no restriction on abortion** she would ever support, and there is no restriction on gun rights she would ever oppose. Carhart, Citizens United and Heller were 5-4 decisions, and Mrs. Clinton wants each of them to be litmus tests for her Supreme Court appointments. She mocks Mr. Trump for saying he won't abide by the election result, but she wants to **rewrite the Constitution to fit her own political views**.





WE ARE OBAMA'S GUINEA PIGS

For the past year, the Obama administration has been running an experiment: Is it possible to make policy more effective by using psychology on citizens?

The nickname is “nudging”—the idea that policymakers can change people’s behavior just by presenting choices or information differently. The classic example is requiring people to opt out of being an organ donor, instead of opting in, when they sign up for a driver’s license. Without any change in rules, the small tweak has boosted the number of registered organ donors in many states.

Nudging has gained a lot of high-profile advocates, including behavioral-law guru Cass Sunstein and former budget czar Peter Orszag. Not everyone likes the

idea—“the behaviorists are saying that you, consumer, are stupid,” said Bill Shughart, a professor of public choice at Utah State University—but President Obama was intrigued enough that he actually hired Sunstein, a law professor at Harvard who co-wrote the best-known book about the topic, “Nudge.”

The president officially adopted the idea last year when he launched the White House’s Social and Behavioral Science Team (SBST), a cross-agency effort to bring behavioral science research into the policymaking process.

NATIONAL FEAST

The Continental Congress proclaimed the first national Thanksgiving in 1777. A somber event, it specifically recommended "that servile labor and such recreations (although at other times innocent) may be unbecoming the purpose of this appointment [and should] be omitted on so solemn an occasion."

Presidents Washington, Adams and Monroe proclaimed national Thanksgivings, but the custom fell out of use by 1815, after which the celebration of the holiday was limited to individual state observances. By the 1850s, almost every state and territory celebrated Thanksgiving.



Many people felt that this family holiday should be a national celebration, especially Sarah Josepha Hale, the influential editor of the popular women's

magazine *Godey's Lady's Book*. In 1827, she began a campaign to reinstate the holiday after the model of the first Presidents. She publicly petitioned several Presidents to make it an annual event. Sarah Josepha Hale's efforts

finally succeeded in 1863, when she was able to convince President Lincoln that a national Thanksgiving might serve to unite a war-torn country. The President declared two national Thanksgivings that year, one for August 6 celebrating the victory at Gettysburg and a second for the last Thursday in November.

Neither Lincoln nor his successors, however, made the holiday a fixed annual event. A President still had to proclaim Thanksgiving each year, and the last Thursday in November became the customary date. In a controversial move, Franklin Delano Roosevelt lengthened the Christmas shopping season by declaring Thanksgiving for the next-to-the-last Thursday in November. Two years later, in 1941, Congress responded by permanently establishing the holiday as the fourth Thursday in the month.

I do therefore invite my fellow citizens in every part of the United States...to set apart and observe the last Thursday of November next, as a day of Thanksgiving and Praise to our beneficent Father who dwelleth in the Heavens. - Abraham Lincoln


